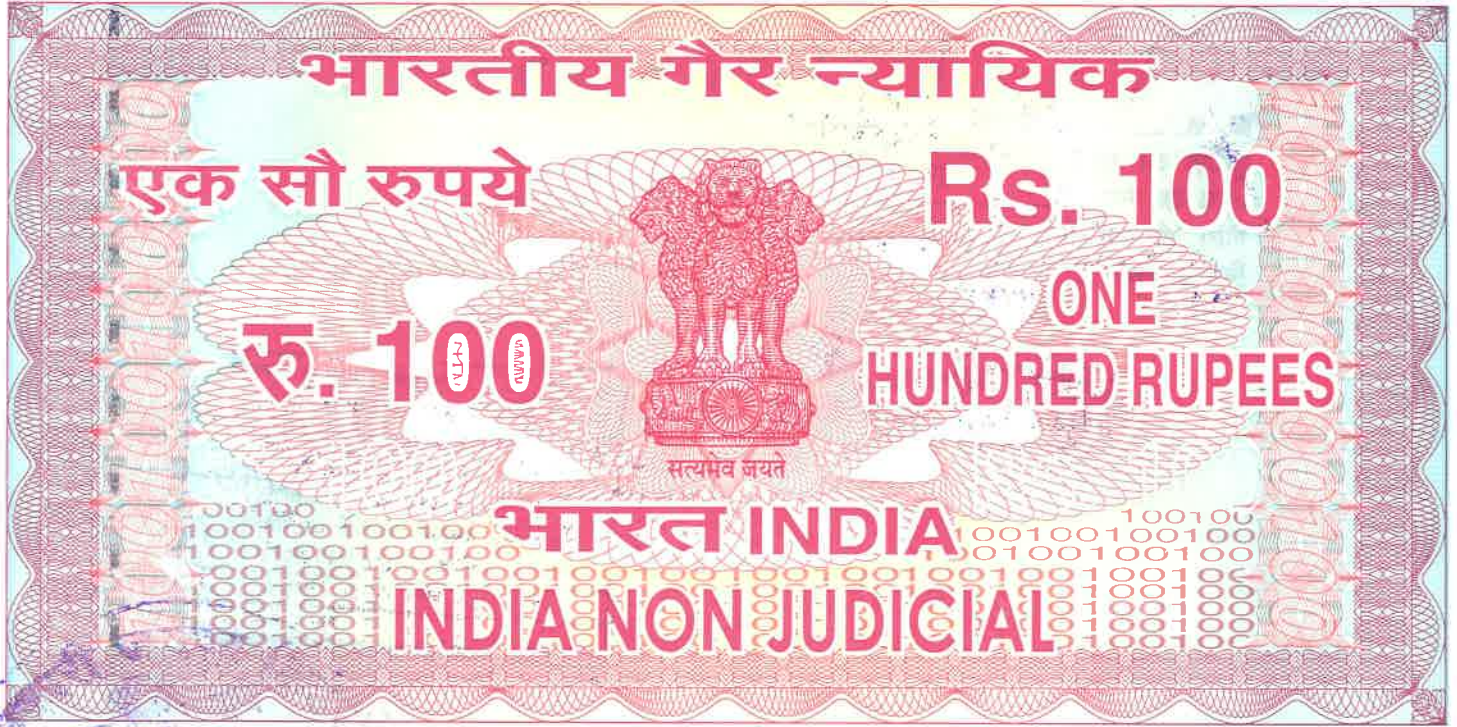

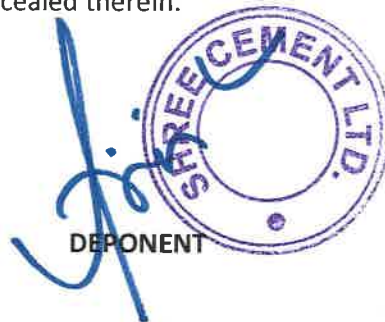



Day Ahead Power Exchange Transactions of Electricity by Trading Licensees





